## Agreement, Assumption of Risk, Release of Liability, and Indemnity Agreement

**Vaccinations:** You must send a record of your dog's vaccination history and due dates along with your registration. The most recent vaccines must have been administered by a licensed veterinarian. Satisfactory antibody titer levels signed by a licensed veterinarian are acceptable for the DHPP vaccine only. Dogs under the age of 16 weeks must have their first DHPP (distemper, hepatitis, parainfluenza and parvo virus) and their first intranasal Bordatella vaccinations at least 10 days prior to the first class attended. Dogs receiving the injectable Bordatella vaccine must have two boosters with the second booster given at least 14 days prior to the first class attended. Dogs over the age of 16 weeks must have received their current Bordatella, DHPP, and Rabies vaccinations at least 7 days prior to the first class attended. Documentation evidencing subsequent required vaccinations must be provided to stay enrolled in the class.

**Dogs Not Suitable for Class:** Some dogs will not thrive in a class environment. Dogs who are uncontrollable, unpredictable, aggressive, and/or overly shy require more individual attention than can be received in a class and will be referred for private consultation. A refund for the remaining classes will be applied to the private consultation.

**Females in Heat:** Female dogs in heat should not be brought on the grounds. Handlers are encouraged to continue attending classes.

**Payment/Refunds:** Class size is limited. Payment reserves your spot in the class requested and must be received by Custom Pet Services, LLC at least 7 days prior to the class start date. Confirmation of receipt of your paid registration will be emailed to the address you provided above. If the class you have chosen is filled or canceled by Custom Pet Services, LLC, your payment will be returned in full or applied to the next scheduled session (at your choice). To receive a refund for cancellation, you must notify Custom Pet Services, LLC, of the cancellation at least 7 days prior to the class start date. Owner/Handlers who do not attend the first class (orientation) will be considered dropped from the class without a refund. Fees are non-refundable and non-transferable other than the circumstances specifically stated in this Agreement.

**Photo Release:** Custom Pet Services, LLC, may use photos and videos taken in class for educational and promotional purposes.

**Assumption of Risk:** Owner/Handler acknowledges that his/her dog may be exposed to a variety of environmental conditions which include, but are not limited to: canine diseases and parasites, interaction with people and other animals, exposure to adverse weather, and exposure to areas with crowds and all types of traffic. Owner/Handler further acknowledges that dog training activities, and the premises on which those activities may be conducted, including animals, people, items and activities thereon, pose dangers to personal property, people, and animals. Such dangers include, by way of example and not limitation: animals that can bite, scratch, trip, knock down, and fight; indoor and outdoor surfaces that may be slippery; equipment that can trip; people who cannot control their animals; and activities involving owner/handler's dog and/or other animals that can result in injury from bites or other causes. Accordingly, Owner/Handler, on behalf of him/her, his/her spouse and minor children, and anyone else whom Owner/Handler exposes to dog training activities conducted by Custom Pet Services, LLC, or to the premises on which those activities may be conducted, assumes the risk of injuries, losses, damages, costs and expenses to them by any means above described, including injury or damage to, illness or pregnancy of, or loss or theft of Owner/Handler's dog, and any other injuries, losses, damages, costs, and expenses of every possible cause and description, that may arise from dog training activities conducted by Custom Pet Services, LLC, or from the premises on which such activities are conducted, and Owner/Handler hereby releases Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and Animal Medical Center, and its officers, employees, owners, members, and agents from liability therefrom. This paragraph applies to injuries, losses, damages, costs, and expenses arising from the negligence of Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and Animal Medical Center, and its officers, employees, owners, members, and agents.

**Owner/Handler's Liability:** If Owner/Handler's dog causes property damage, or bites, or injures any animal or person, during or after the term of this Agreement, while in the possession of Custom Pet Services, LLC, or otherwise, then Client agrees to defend, indemnify, and hold harmless Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and Animal Medical Center, and its officers, employees, owners, members, and agents and its agents and employees from any resulting claims, demands, lawsuits, losses, costs, or expenses, including attorneys fees, and to pay all losses and damages suffered or incurred by Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and Animal Medical Center, and its officers, employees, owners, members, and agents as a result of those claims, demands, or lawsuits, regardless of whether such claims, demands, or lawsuits

arise from the negligence of Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and/or Animal Medical Center, and its officers, employees, owners, members, and agents. Further, Client agrees to pay all losses and damages resulting from any behavior of his/her dog that causes property damage or personal injuries to Custom Pet Services, LLC, and its officers, employees, owners, members, and agents and/or Animal Medical Center, and its officers, employees, owners, members, and agents.

**Termination:** I understand that Custom Pet Services, LLC, has the right to refuse service to me and/or my dog at any time for any reason. I recognize that all bites will be reported to local authorities as required by law. At Custom Pet Services, LLC's sole election, Custom Pet Services, LLC's duties hereunder shall terminate if (a) in Custom Pet Services, LLC's, sole judgment Pet is dangerous or vicious to any person or animal, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Custom Pet Services, LLC's duties shall terminate, but all other provisions of this Agreement shall continue in full force and effect.

**Legal Provisions:** This Agreement is binding upon Owner/Handler, the spouse of Owner/Handler, the children of Owner/Handler, and Owner/Handler's heirs, assigns, and personal representative. This Agreement supersedes all prior discussions, representations, warranties, and agreements of the parties, and expresses the entire agreement between Owner/Handler and Custom Pet Services, LLC, regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations, or oral understandings have been made with regard to the dog or anything else. Owner/Handler understands that the recommendation of any product or service is not a guarantee of satisfaction with that product or service. Without limiting the generality of the foregoing, Owner/Handler acknowledges that Custom Pet Services, LLC, has not represented, promised, guaranteed, or warranted that his/her dog can be trained, that his/her dog will never bite, that his/her dog will not be dangerous or vicious in the future, that his/her dog will not exhibit other behavioral problems, or that training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by Owner/Handler and Custom Pet Services, LLC. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this Agreement is invalid, void, or unenforceable, it will be severed and the remaining provisions shall be given full force and effect.

I am entering into this Agreement in partial consideration for the services to be provided by Custom Pet Services, LLC. I have read, understand, and agree to all terms and conditions set forth above. I understand that I have given up substantial rights by signing this Agreement and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me.
